I ..... hereby declare that:

- □ I have read the information package online and I agree to comply with the rules of behaviour reported therein
- □ I am aware that this programme is about conservation and not just a wildlife watching experience
- □ I will do nothing to harm or disturb wildlife as laid out in the rules of behaviour contained in the information package
- □ I will always show respectful behaviour to third parties whilst a representative of the host organisation, especially during all host organisation activities
- □ The host organisation has given me a health and safety induction and I will act accordingly at all times
- □ The host organisation representative has answered and clarified all my questions and concerns regarding the information package and the health and safety induction
- □ I will inform my tutor or the host contact about any health and safety issues, allergies or food intolerance
- □ I have been made aware of the local emergency numbers
- $\Box$  I have been vaccinated against tetanus in the past 10 years
- □ I understand that all the activities I have agreed to take part in are voluntary
- □ The host organisation has made clear that all the activities are voluntary and therefore I can freely choose whether or not to take part in them
- □ I will complete the self-evaluation skill assessment form or any similar form supplied by my University, School, Institution, or Host Organisation (if required) prior to the ending of the internship
- □ I will generate a weekly activity report which shall be passed to the host organisation tutor every weekend
- □ I have saved the contact details and phone numbers for all personnel and tutors of the host organisation
- □ The host organisation can use □ cannot use □ my image for promotional and marketing purposes either in print or through online publications (website and social networks). Please indicate preference by ticking the relevant box
- □ I will make the host organisation contact person or tutors aware of any concerns or suggestions I might have regarding the volunteer work, including any difficulties with other participants or even activities during the internship to help improve future programmes
- □ I will be held responsible for any damage to the accommodation and will be required to pay for it
- □ I will minimise food and household utilities waste according to the hosting organisation ethics
- □ I will dispose of waste or recycling according to the town rules
- □ I will handle all tools supplied by the host organisation in a responsible manner and will be held liable to pay for them should any be broken due to my negligence
- □ I will communicate my departures or arrivals to the volunteer work location giving adequate notice (at least 7 days); the same goes for any planned holiday trips which I expect to take
- □ I am aware that any planned holiday trips should never interfere with the volunteer work and therefore I should never expect the hosting organisation to repeat the scheduled activities which I may have missed during my holiday
